rebuilding and recovery, GFWC clubwomen stand out as community leaders and are among the first to offer assistance.

Only two days after Hurricane Harvey made landfall 30 miles north of Corpus Christi, Texas President Patti Poe established the [GFWC Texas Hurricane Relief Fund](#). Clubs from California to Maine have contributed to the fund donating an astounding \$95,000! Immediately following the storm, financial gifts were used to purchase water, food, and other essentials needed by individuals forced to flee their homes. Today, funds are being allocated to help with long-term rebuilding efforts. For example, a relief check was presented to Camp Aranzazu to repair their recreation facility. The camp provides therapeutic programs that are designed to enrich the lives of children and adults with special needs and chronic illnesses. A donation was also presented to Dianne Browne, a member of GFWC Woman's Club of Aransas Pass. Dianne operates a daycare that was severely damaged during the storm. Additional funds received will be given to local libraries so that their doors may reopen once again. President Poe sends "A big Texas thank you!" to everyone who has contributed to the fund.

GFWC Florida President Mary Powell is also grateful for the assistance provided by clubwomen in the wake of Hurricane Irma. She recently stated, "Florida is well on its way to recovering from the hurricane, and we are thankful for your generous donations. We are in this together, and together we will succeed. GFWC Florida appreciates all that you have done and continue to do to help your Federation sisters who suffered. You are truly the best!" While great strides have been made in Florida, at least one club continues to face difficulties. The historic clubhouse owned by the [Bradenton Woman's Club](#) experienced extensive structural damage. Club members are currently raising funds to replace the building's roof and restore the interior.

Reconsider or Rescind?

Reconsider should be used in the same meeting as the motion that is to be reconsidered was made, or the next business meeting.

Rescind can be used anytime, without regard to when the motion was adopted. Rescind at any later time but may require previous notice.

Reconsider requires a second, is not amendable and is debatable only if the motion to be reconsidered is debatable, in which case, debate can go into that question.



GFWC Attends the Annual Veterans Day Briefing

On November 7, GFWC was represented by Public Policy/Legislation Chairman Becky Weber at the [Women's Congressional Policy Institute's](#) annual Veterans Day Briefing. This year's event addressed health challenges facing women veterans following deployment. Speakers included: Dr. Carolyn Clancy of the Veterans Health Administration; Shurhonda Love a service-connected disabled veteran and representative of the Disabled American Veterans; and Allison Jaslow the Executive Director for Iraq and Afghanistan Veterans of America.

Chairman Weber receives weekly briefings from the Women's Congressional Policy Institute. Recent publications have focused on women's preventative health; reducing maternal mortality in the developing world; women in science, technology, engineering, and math (STEM); the gender wage gap; and economic security for women and families.

In the News

Legislative Action Corner

Federal Appropriations for Family Violence Prevention

Current federal funding for programs to assist domestic violence shelters, rape crisis centers, and programs to help victims of child abuse, among others, expires December 8 and Congress must either pass an omnibus FY 2018 spending bill or another short-term continuing resolution to keep the programs going. If neither is approved, there will be a government shutdown and no services funded by federal dollars can be provided. If you see your member of Congress during the Thanksgiving holidays, please urge them to pass an omnibus spending bill, so these programs can do this important and critical work in our communities.

Tax Reform

Both the House of Representatives and the Senate are considering comprehensive tax reform proposals. Congressional leaders and the White House hope to have a final bill before the end of the year.

Important to GFWC are the proposals regarding:

- Increasing the charitable 14 cents mileage rate deduction for volunteers (GFWC Resolution 015-660 Valuing Volunteers); and
- Allowing tax deductions for medical expenses (GFWC Resolution 013-270 Long-Term Care).

In addition, the Charitable Giving Coalition strongly urges the inclusion of a universal charitable deduction available to all taxpayers. This would assure that contributions to 501(c)(3) charities are not taxed by the federal government and that taxpayers who currently take the deduction for their gifts will continue to be incentivized. The Coalition is concerned that doubling the standard deduction and providing a short-form for filing will dramatically reduce the number of taxpayers who make charitable donations. The Congressional Joint Committee on Taxation estimates such action will result in a loss of \$100 billion over ten years. Therefore, the Coalition urges Congress to provide a way for all taxpayers to obtain deductions for charitable contributions, regardless of whether they itemize. The

overall goal is to ensure that our communities and charities thrive and remain strong, diverse, and effective.
