## **Shot@Life Advocacy and Fundraising Event Grants**

*Thanks to the United Nations Foundation's Shot@Life Campaign, GFWC is pleased to offer grants to help host advocacy and fundraising events, in amounts of up to \$100, to help put a stop to preventable childhood diseases globally.*

These funds, provided by the United Nations Foundation, are to be used to plan local advocacy events and fundraisers for the Shot@Life Campaign. Clubs may use funds to plan their event/fundraiser with a goal of raising more than the original amount awarded. Please read over the guidelines found below, decide on your club's fundraising project, and complete and submit an application. Simply develop and implement a worthwhile fundraising project, and when finished, complete the easy evaluation form.

### **APPLICATION GUIDELINES**

- Clubs should assign a chairman responsible for managing the fundraising activities.
- Clubs should briefly describe what type of activity they will be conducting to boost fundraising at the club level.
- Clubs should provide a budget describing how the funds will be used.
- Clubs should set goals to either:
  - **FUNDRAISING EVENT**: Raise more than the grant amount to help these children. Every \$20 raised is enough to provide a child protection from four of the most infectious diseases.
  - **ADVOCACY EVENT**: Have at least 10 people in attendance of event, which would focus on an advocacy event. For example, a 1-hour phone-bank to make 5 calls (one call into each of your three Congressional offices + two calls to friends to ask them to do the same).
  - **BOTH**: The ideal event would combine elements of both advocacy and fundraising.

**DEADLINE: Funds will be distributed on a rolling basis while funds are still available, but must be used and reported on by the end of the year.** Events during Shot@Life activations are highly encouraged and will be given preference. For more information, contact [champions@shotatlife.org](mailto:champions@shotatlife.org). Clubs must also submit a final evaluation/summary of the event to GFWC headquarters.

**FUNDS RAISED:** Funds raised should NOT be sent to GFWC. Funds should be sent to the Shot@Life Campaign. Please make sure to put your club name and state on every check so that these funds will be counted towards the Shot@Life Awards Program!
