on September 30**

In support of GFWC's Inaugural National Day of Service, GFWC Staff

will be battling food insecurity by doing food prep at [DC Central Kitchen](#) (DCK). DCK combats hunger and poverty through job training and job creation by providing hands-on culinary training for individuals facing barriers to employment. They create living wage jobs and bring nutritious, dignified food to those who most need it. DCK serves scratch-cooked-farm-to-school meals in DC schools, delivers fresh, affordable produce to corner stores in neighborhoods without supermarkets, and operates fast-casual cafes throughout DC where many newly trained food workers hone food preparation skills.

## Legislative Corner

*To encourage participation in the democratic process, this monthly column aims to inform members about current legislation and programs that are germane to the GFWC Resolutions. It also highlights important actions of Congress and the White House, and provides follow-up information about GFWC Legislative Action Alerts.*

Food Insecurity: The GFWC Legislation/Public Policy Committee is urging each clubwoman to join the GFWC Legislative Action Center and take action on the alert to increase funding for Meals on Wheels and reauthorize nutrition programs in the Farm Bill. [View Alert](#). This alert was sent to those registered for the Legislative Action Center on Monday. We hope all clubwomen will take action!

Hunger and malnutrition are not easy problems to solve, and families face challenges around housing, inflation, lack of transportation,

health care, and availability of nutritious food in both urban and rural food deserts. Let your National Day of Service project spark a more comprehensive advocacy campaign to address your community's root causes of food insecurity. Ask food drive donors and recipients of food collected to use their voices to support this important legislation.

Federal Appropriations: It appears likely that Congress will not reach an agreement to fund federal programs by September 30, 2023, the end of the federal fiscal year. A government shutdown affects federal programs, services, and employees differently. For example, Social Security payments will continue, but the State Department cannot issue passports. National parks will be closed. In prior shutdowns, border protection, in-hospital medical care, air traffic control, law enforcement, and power grid maintenance have been among the services classified as essential, but employees will work without pay until Congress approves the appropriations for the fiscal year that begins October 1, 2023.

STOP Online Child Sexual Exploitation: Bills are being readied for floor action in the House of Representatives and the Senate to combat online child sexual abuse. GFWC recently cosigned a coalition letter urging Senate leaders to bring a package of 5 bills to the floor. [View Letter](#). Look for a GFWC Legislative Alert in mid-October that is timed to assist with the advocacy efforts coordinated by the National Center on Sexual Exploitation.
