Brazil as the 55th GFWC International President of the General Federation of Women's Clubs (GFWC) in Chicago occurred, marking a historic moment as the first International President from Alabama in GFWC's 134-year legacy. With a bold vision, Brazil has set out to educate, engage, and empower GFWC members across the nation and the world. She aims to ignite purposeful conversations and equip members with the tools needed to effect real change in their communities.

First 100 Days: Key Accomplishments

In her first three months, GFWC International President Brazil and her dedicated team have made impressive strides in making powerful connections that together can create meaningful and lasting change.

August Highlights

Empowered to Action: Brazil's first major event hosted the full GFWC Board of Directors in Washington for a weekend of leadership training and education. Her selection of panelists included federal officials and experts in the field of domestic and sexual violence awareness and prevention.

Legislative Advocacy: Brazil, alongside Programs and Public Policy Specialist Kynnedi Taylor-Henry, met with Congressman Dale Strong to advocate for crucial funding increases for the Violence Against Women Act and the Kids Online Safety Act. These initiatives aim to protect minors from harmful online content and promote safe digital environments.



COLLABORATION FOR CHANGE

Collaboration for Change: At GFWC Headquarters, Brazil hosted Stephanie Love-Patterson, President of the National Network to End Domestic Violence. They discussed ways to strengthen partnerships in the fight against domestic violence, underscoring GFWC's commitment to this critical issue.

Global Perspectives: Madame President attended the Coalition to End Sexual Exploitation Global Summit, co-hosted by GFWC's partner, the National Center on Sexual Exploitation. This summit brought together diverse stakeholders to explore how technology can be leveraged to safeguard children and enhance protective policies.

Supporting Young Caregivers: Brazil participated in the Elizabeth Dole Foundation's Hidden Helpers Summit, focusing on the unique challenges faced by adolescent caregivers of wounded service members. This initiative aims to enhance support services for these young caregivers and their specific needs.

Global Immunization Advocacy: In collaboration with Shot@ Life, Brazil hosted a virtual Mobilize to Immunize Fall Summit. Participants engaged with global health experts to prepare to advocate for robust U.S. funding for childhood immunization programs.

Domestic and Sexual Violence Advocacy: Brazil and GFWC Legislative Consultant Debby Bryant celebrated the 30th anniversary of the signing of the Violence Against Women Act with key national leaders, celebrating progress made and highlighting ongoing efforts to combat domestic violence.

Engaging Membership: In a unifying stance against food insecurity and hunger, GFWC registered over 1,000 groups for the 2024 GFWC National Day of Service, reinforcing the spirit of community service.

International Collaboration: Joined by President-elect Wendy Carriker, Madame President traveled to Aruba to celebrate the

90th Anniversary of the GFWC Women's Club of Aruba. During this visit, they met with Interim Governor of Aruba Agustin Vrolijk and Prime Minister Evelyn Wever-Croes to discuss domestic and sexual violence prevention. Their collaboration with local authorities emphasized the importance of raising awareness and offering educational solutions to social challenges.

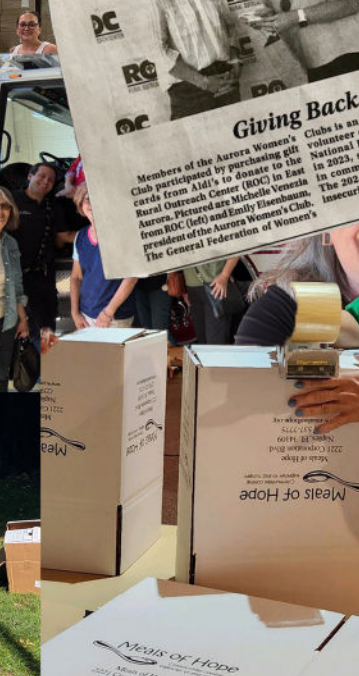
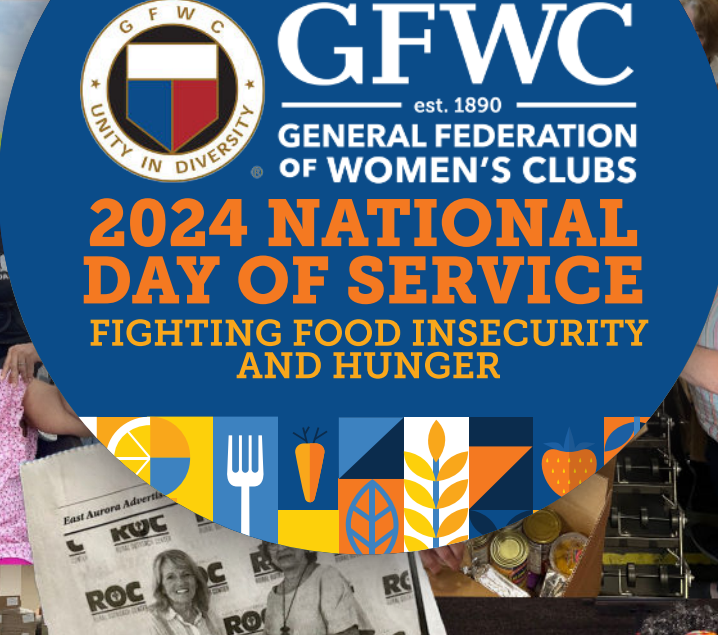

GFWC NATIONAL DAY OF SERVICE RECORDS MORE THAN 1,100 CLUBS NATIONALLY AND INTERNATIONALLY

The second annual GFWC National Day of Service (NDS) on September 28 tallied more than 1,100 clubs participating. GFWC club members nationally and internationally rallied to raise public awareness about food insecurity and hunger, collecting hundreds of thousands of pounds of nonperishable food items for their local communities. GFWC Miami Springs Woman's Club

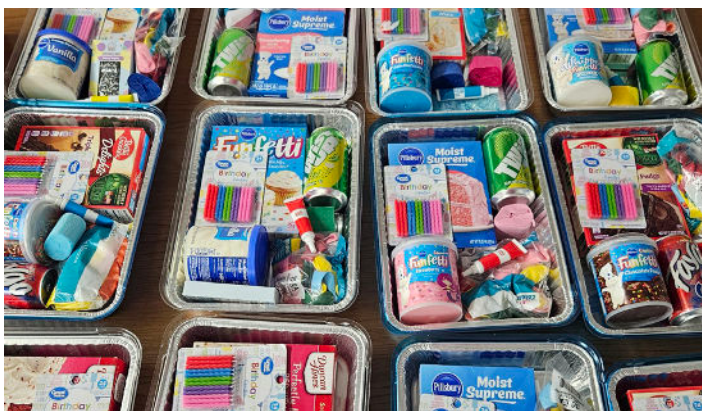

"The General Federation of Women's Clubs has been a force for good in this country for more than a century," said Anna Laymon, President and CEO of the Women's Suffrage National Monument Foundation. "GFWC's commitment to women's equality began in 1868 when journalist Jane Cunningham Croly attempted to attend a dinner at an all-male press club honoring British novelist Charles Dickens. GFWC's history is the history of women's fight for equity and inclusion, and we are honored to be one more chapter in GFWC's story."

In honor of the partnership, GFWC has established a fund to raise \$150,000 for the monument, with a \$26,000 founding gift for the fund to be contributed by Colonel Carol A. Habgood, USAF Retired, GFWC Parliamentarian, PRP.

GFWC's donation is an important step towards the Foundation's \$75 million fundraising goal. Laymon added, "We extend our deepest gratitude to GFWC International President Suellen Brazil; GFWC

GFWC LEADERS CELEBRATE 90 YEARS OF COMMUNITY SERVICE WITH THE GFWC WOMEN'S CLUB OF ARUBA

PRIME MINISTER OF PARADISE

Members of the Woman's Club of Aruba, Women's Steering Committee Curacao, Sentro di Dama Curacao, and GFWC Executive Committee members were honored to meet with Prime Minister Evelyn Wever-Croes.

GFWC International President Suellen Brazil and President-elect Wendy Carriker joined the GFWC Women's Club of Aruba (WCA) to celebrate its 90th anniversary. Founded in 1934 and an International Affiliate since 1937, GFWC Aruba has been a key partner in community service.

On Monday evening, GFWC leaders experienced the warmth and hospitality of the Caribbean club's leadership before kicking off three days of anniversary events. Brazil and Carriker met with Mrs. Reina Geerman, President of the Women's Club of Aruba, and Past President Mrs. Omaira Silva, along with Interim Governor Mr. Agustin Vrolijk at the Governor's office. Their discussions centered on initiatives advocating for women's rights, leadership, and community development, with a significant focus on combating domestic and sexual violence. Both organizations shared their efforts to raise awareness and offer solutions through educational programs.

Later that afternoon, GFWC and the Women's Club of Aruba visited Fundacion Pa Nos Comunidad (FPNC), the island's only food bank, to learn about its work supporting families in need. The Women's Club of Aruba has volunteered with FPNC for their past two GFWC National Day of Service Projects.

The groups also met with Prime Minister Evelyn Wever-Croes to discuss key initiatives to advance women's rights, leadership, and community development. Additional topics included domestic and sexual violence and the critical role of educational programs in combating social challenges. The delegation meeting with the Acting Governor and the Prime Minister included key leaders from the WCA, Women's Steering Committee Curacao, and representatives of the Fundashon Sentro di Dama (SEDA) Curacao.

To conclude the event, the Women's Club of Aruba launched "90 Mata pa 90 Aña" (90 Trees for 90 Years), planting the first Palo di Boonchi at the National Library of Aruba. This initiative reflects their commitment to sustainability and aims to revitalize the endangered Palo di Boonchi population, which currently numbers only 30 to 40 trees in the wild.

To preserve their legacy, the Women's Club of Aruba submitted its entire collection of historical documents dating back to its founding in 1934 for digitization and preservation at the National Library of Aruba. This ensures public access to historical records that document the impact of clubwomen in their community.

After almost a century of partnership, the General Federation of Women's Clubs and the Women's Club of Aruba exemplify the strength of collaboration in making a difference. Their commitment to volunteer service ensures Aruba continues to be "One Happy Island."

Clubwomen and community members celebrated the anniversary with a grand gala featuring local music. The history of the Women's Club of Aruba was shared by Past President Omaira Silva. GFWC International President Brazil presented the club with a special certificate and commemorative granite emblem to recognize their milestone anniversary.

will generate a final report, helping us to prioritize our collection care efforts.

This project ties neatly into the new Annual Giving option for the 2024-2026 Administration: the WHRC Art & Artifacts Fund. Thanks to assessments and surveys such as the CAP program, we can be assured that the money raised for this fund is directed toward conserving the works at most risk, and toward improving storage and display conditions for the better preservation of the whole collection—including our historic Headquarters itself.

In other WHRC news, renovations at Headquarters are continuing. Last year the Archives Room got new flooring, paint, and light fixtures; now it's the Reference Library's turn for a refresh, along with other staff offices and artifact storage rooms on the 2nd and 4th floors of 1728 N Street. Although this means that some of the reference collection is packed up while the Library gets its face lift, we will still do our best to answer inquiries. Research requests for club members, scholars, and other organizations can be handled over phone or email, or in person. For example, we've recently hosted some on-site researchers, **including an author looking into GFWC's work on state birds in the 1920s-30s**, a local college student writing her thesis on GFWC in the post-World War II era, and our own Pam Briggs, Western States Region President 2024-2026, who is researching the history of the Oregon Federation.



We're also working on adding content to the GFWC History page on the website, such as photos of all 54 International Past Presidents, some background on Headquarters, and a new WHRC "From the Archives" blog series, posted on the first Thursday of every month. Do you have

AUTUMN AT THE WHRC

This season brings exciting news to the GFWC Women's History and Resource Center, as we are proud to announce that we are one of 71 institutions across the U.S. who have been selected to participate in the Collections Assessment for Preservation (CAP) program. The CAP program, administered by the Foundation for Advancement in Conservation (FAIC) through a cooperative agreement with the Institute of Museum and Library Services (IMLS), provides support for a general conservation assessment of both collections and buildings. This holistic approach is especially important for organizations like GFWC, as we not only hold our archival, art, photograph, and artifact collections in historic buildings, we also regard the historic buildings as part of the collections. GFWC Headquarters and the treasures within its walls will benefit equally from this fantastic and competitive program.

How it works: This November, a small team of professional consultants will spend two days at GFWC Headquarters, surveying the buildings and collections. Through this assessment—as well as through conversations with GFWC staff, EC members, WHRC Committee members, and our building contractors —this team

GFWC FACADE RESTORATION & BEAUTIFICATION PROJECT

PROTECTING AND PRESERVING THE FUTURE OF 1734 N STREET

GFWC is rightfully proud of our historic Washington, DC Headquarters. These three nineteenth century rowhouses are home to our work, our history, and—literally—our leadership. The central building, 1734 N Street, has been part of GFWC for over a century; in recognition of that history, it was named a National Historic Landmark.

While we make good use of these buildings in our day-to-day work, as custodians of these historic structures it is our responsibility to care for them. Without maintenance and, where needed, preservation, our Headquarters buildings cannot withstand the test of time and support us for another hundred years. This project seeks to secure and preserve our buildings for the future.



A CLOSE UP LOOK

From the sidewalk, GFWC headquarters towers majestically, but upon closer inspection, the years of exposure to the elements are clear. In this photo you can see cracked exterior paint and mortar on the east side of the 1734 building.

Currently, the deteriorating stone work around the bricks on the front facades allows water inside, leading to structural and interior damage. The walls of GFWC headquarters contain significant works of art, most of which were gifted by GFWC State Federations during the 1920s GFWC Department of Fine Arts campaign of "Art for Everyone-and Everyone for Art." Some of the most prominent art in our collection resides in the Drawing Room on the second floor of 1734. Thirteen murals by Albert Herter decorate the long entertaining room now used for main events. The panels of these murals that reside on exterior walls face the threat of water infiltration through the damaged brick exterior.

As we work to update and repair existing damage, we also seek to prevent further damage to the working offices and historic spaces on our buildings. Water damage has caused aesthetic and structural problems in all three of our properties over the years. The evidence of this can be clearly seen in the front entrance of 1728.



A WATERFALL OF DAMAGE

Frequent undetected water damage is responsible for the crumbling appearance of this corner inside the entrance to 1728. Without proper sealing treatments on the exterior of the building and roof problems like this one will persist.

The main project will involve removing the old flaking mortar from between each brick and refilling the space with new mortar. This process increases the resistance to weather and supports the wall's structural integrity. Good repointing practices guarantee the long life of the mortar joint, the wall, and the historic structure.

We will also clean and repair the decorative limestone cornices and railings that give 1734 a distinct character. Limestone is porous, which means that water can soak into the stone and cause damage that is not visible from the outside. Over time, the water inside the stone can freeze and expand, causing cracks and endangering the structure of the limestone. With each passing year the chance of these distinctive limestone pieces detaching from our façade increases.

Notice the distinctive water marks from water damage on this corbel supporting the railing on the third floor of 1734. As water seeps inside the porous stone it weakens the structure of the carved limestone. Cleaning and sealing techniques can help preserve the intricate details on these hand crafted works for future weather.

Preservation experts are scheduled to visit GFWC Headquarters this fall to analyze the extent of the damage and provide us with recommendations for matching historic techniques and materials to our existing structures. We look forward to updating you on their findings and, with your help, preserving our historic home for years to come.

SHINING A LIGHT ON COURAGE

GFWC TEXAS BOARD AND STATE PRESIDENT BARBARA HARVEY TACKLE HUMAN TRAFFICKING

In a world where some subjects remain difficult to address, it takes immense courage to dive into the uncomfortable truths that so often go unnoticed. The General Federation of Women's Clubs (GFWC) Texas Board, led by their 2024-2026 State President, Barbara Harvey, and GFWC Texas Signature Program Chairman, Beth Hemby, have done just that—shining a powerful spotlight on one of the darkest issues in our society: human trafficking.

During the GFWC Texas 128th Fall Board meeting, President Barbara Harvey took a bold step by inviting Hope For Justice, a global organization dedicated to ending human trafficking, to present to the members. Hope for Justice representatives, Amanda Jacobi and Dr. Richard Schoeberl, Lead Investigator specializing in trafficking cases, delivered a profound and eye-opening presentation. Their discussion, filled with vital statistics, illuminating facts, and key signs to recognize human trafficking, underscored the grave reality that this heinous crime is more prevalent in the United States than many realize.

Human trafficking is a topic of immense significance but one that remains shrouded in silence for far too many communities. The statistics presented by Dr. Schoeberl revealed just how pervasive and destructive this crime is, targeting vulnerable individuals across the country and impacting families and communities.

President Barbara Harvey, Chairman Beth Hemby, and the GFWC Texas Board deserve praise for their willingness to tackle such a heavy and deeply concerning issue. It would have been easier to choose a less daunting topic, but true leadership doesn't avoid uncomfortable truths—it confronts them head-on. Their decision

to focus on human trafficking exemplifies the spirit of GFWC women: resolute, compassionate, and fearless.

GFWC Texas members are transforming their newly acquired knowledge on human trafficking into meaningful advocacy. On May 13th, they will hold an Advocacy Action Day at the Texas State Capitol, where they will urge legislators to take decisive steps toward protecting victims of human trafficking. Members will attend both House and Senate sessions and meet individually with legislators representing their communities, emphasizing the critical need for stronger protections and support for trafficking victims.

As GFWC Texas clubwomen return to their communities, equipped with this newfound understanding, they are ready to join the fight to protect the vulnerable, raise awareness, and stand up for justice. Because of leaders like GFWC Texas State President Barbara Harvey and Chairman Beth Hemby, the conversation has started—and it's not stopping any time soon.
